I have called and left a message a couple of months back.
I'll give him another call.

Its another story of a parent killing his daughter and committing suicide. I have seen so many suicides due to this kind of child abuse & domestic violence it sickens me.

To know that I went through the same thing (without the suicide obviously), losing my connection with my children (Not having had time with them in 5 years, no calls, texts, nothing.) and losing almost everything I ever owned including the 5 million dollars worth of property/business/Personal property. 1 week I lost my businesses, my place to stay, and my income.

It staggers me that when trying to file complaints, especially child abuse and domestic violence it has to be escalated because it's touchy.

I have known you for quite a while, and I have witnessed you have always seemed to be pretty straight up, it saddens me to have to escalate this.
